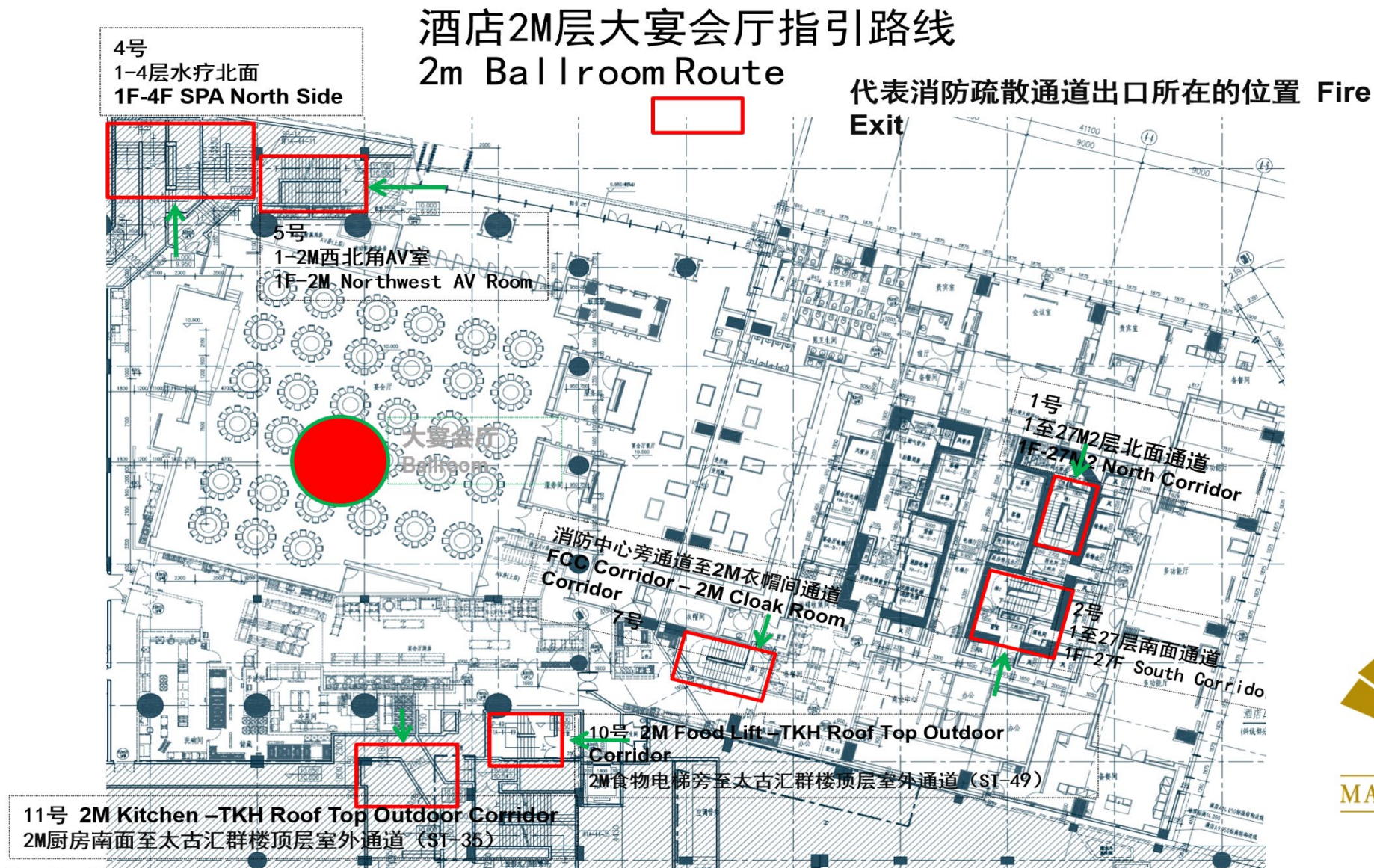

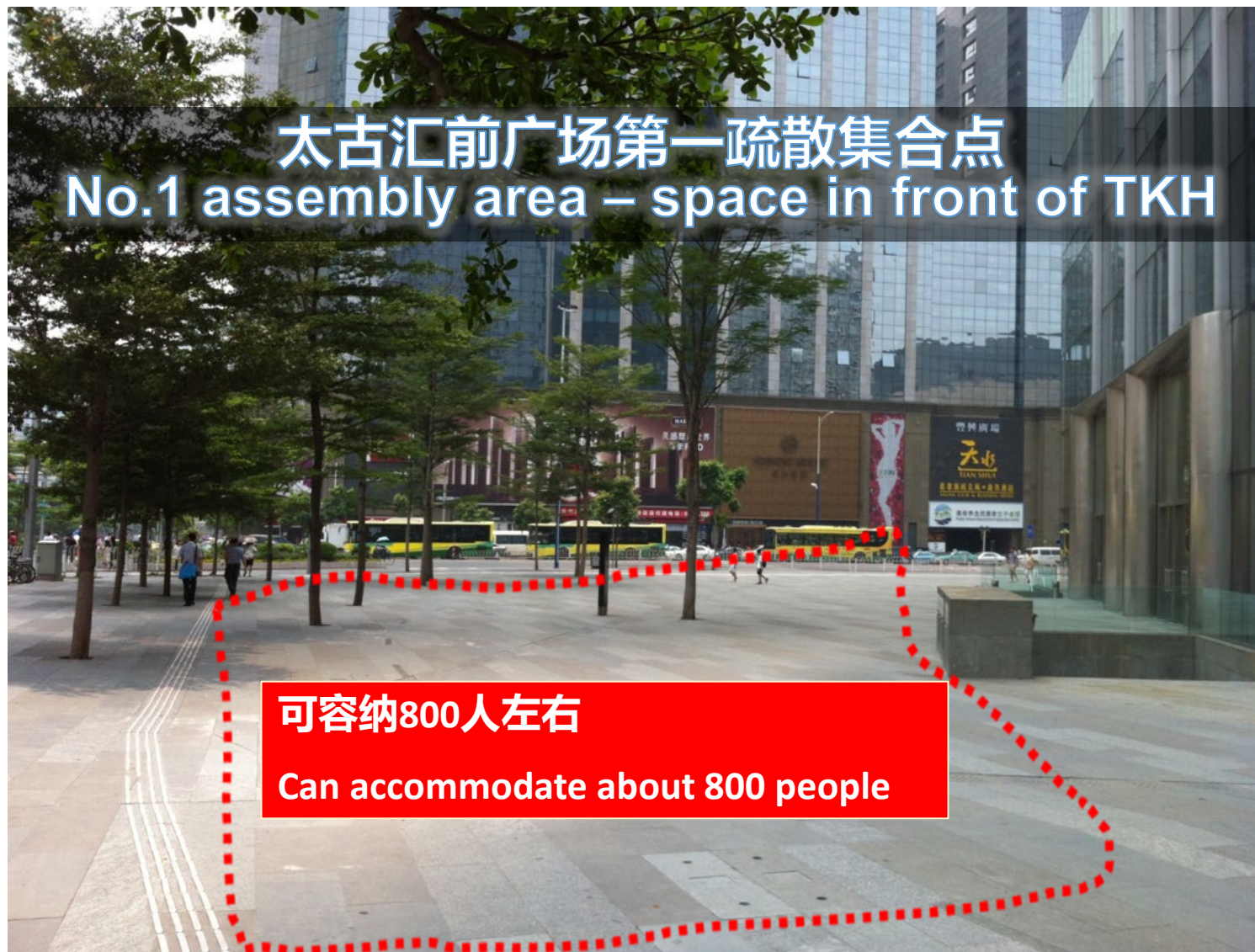
## 酒店楼层疏散指引路线 Hotel Route
